Support for the Ethiopia Refugee

Eligibility for Window 1 & 2

- All applicants must be able to demonstrate how their proposed project will benefit refugees and host communities
- Your business must be able to sign a grant agreement with MoLS should you be successful in applying for a grant.
- You must have the relevant business license renewed for the latest year
- You must also have a Tax Identification Number (TIN).
- Your business must also have a dedicated business bank account in order to receive the grant

What is the challenge fund for?

The Ethiopia Jobs Challenge Fund provides grants to business to create jobs for refugees and host communities and provides grants to Technical and Vocational and Training (TVT), Entrepreneurship Centers and other incubators that support early-stage entrepreneurs in Ethiopia from refugees and host communities.

Ethiopia Jobs Challenge Fund Implementer

The Ministry of Labor and Skills (MoLS) working in cooperation with various relevant stakeholders are the implementers of the Challenge Fund and successful applicants will be provided grants by MoLS.

Challenge fund applicants

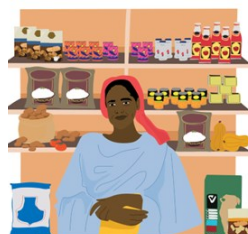
We welcome concept notes from business applicants under window 1 and window 2 and incubators and accelerators under window 3.

Mode of disbursement

Grant payments will be made in installments and grantees will need to report satisfactorily on how monies have been spent before further payments are made.

Challenge fund applicants should be able to demonstrate how the challenge fund could:

- Achieve tangible outcomes and positive impacts on entrepreneurship support systems, business of all sizes that are relevant to refugees, and host communities
- Drive commercial scalable opportunities through co-development and potential procurement of the new (innovative) solutions
- Build local wealth and deliver social benefits and solve societal challenges



Currently the focus of the Fund is restricted only to businesses operating in **Addis Ababa city administration**. Applicants must be able to evidence this.

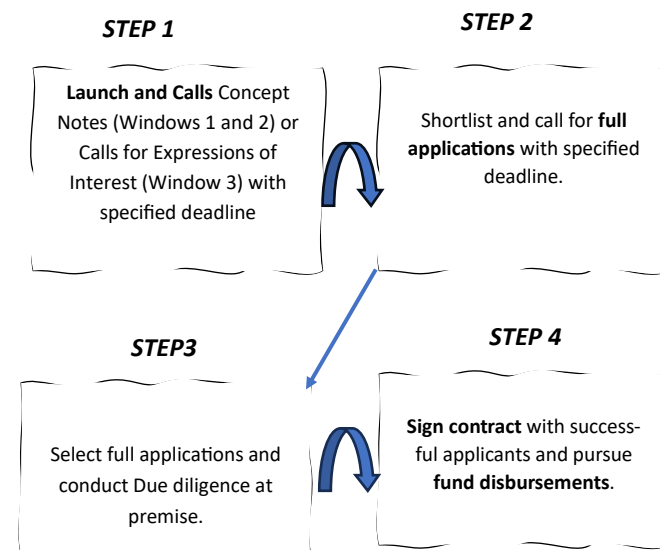
Types of Funding Windows

Operationalized through **open calls for proposals**, the fund comprises **three funding windows** applying different routes to reach **Refugees and Ethiopians** as beneficiaries:

window type	scope of beneficiaries	applicants	funding requirement	end beneficiaries
Window 1:	Business Window Pilot Grants	Legally registered Start-ups and Early-stage Business	Between 10,000 Euro and 20,000 Euro	Refugees, Ethiopians (Host communities)
Window 2:	Business Window Scale-up Grants	growth and larger established businesses	Between 20,000 Euro and 200,000 ¹ Euro	
Window 3:	Incubator and Accelerator Window	incubators, accelerators, and entrepreneurship centers seeking funding to support cohorts of entrepreneurs/start-ups	Between 10,000 Euro and 20,000 Euro	

¹ Applicants are strongly encouraged to request amount closer to the lower end of this range and ensure that proposed budgets are realistic and well-justified. Overestimated budgets, among other factors, may reduce the chances of success in the grant competition.

Timeline for Calls for all Funding Windows

The Challenge fund project will have a number of calls for each window throughout its lifetime which will be notified on its website and related social media channels. The challenge fund is currently seeking concept notes in response to the second calls under the three windows.

Platforms for calls

The call is publicized on the MoLS website and associated news outlets and social media. Interested parties receive replies for their questions through Frequently Asked Questions (FAQs) platform to avoid the Fund getting into direct dialogue with applicants before they have submitted their Concept Notes or expression of Interest.

The project avails an interactive website and detailed steps to guide interested parties how to apply for the fund.
